

SCHEDULE D — SHORT FORM NOTICE (PRE-APPROVAL)

AUTHORIZATION OF A NATIONAL CLASS ACTION AND OF A SETTLEMENT APPROVAL HEARING
BEFORE THE SUPERIOR COURT OF QUÉBEC (*Ohayon v. Dollarama S.E.C.*, no. 500-06-001243-233)

If you purchased a product subject to environmental handling fees from Dollarama in Quebec between December 11, 2019 and July 4, 2023, or elsewhere in Canada between May 29, 2021 and July 4, 2023, you are a member of a national class action.

A proposed national Settlement has been reached in a class action about prices displayed and charged by Dollarama for products subject to environmental handling fees (“**Ecofees**”) it sold in Canada, such as batteries or certain electronic products. The Plaintiff alleged that Dollarama did not properly display the price of these products and charged a price or Ecofees higher than the one displayed or allowed by law. Dollarama denies any liability or wrongdoing and no Court has concluded in any wrongdoing on its part. The Court will hold a hearing on **December 2, 2024** to decide whether to approve the Settlement before any compensation is provided to Class Members.

Am I a Class Member? You are a Class Member if you purchased a product subject to Ecofees from Dollarama in Québec between December 11, 2019 and July 4, 2023, or elsewhere in Canada between May 29, 2021 and July 4, 2023. What can I get from the Settlement? Subject to Court approval, Dollarama has agreed to pay a total amount of \$2,643,718.75 (the “**Settlement Amount**”) to settle the claim. The amount distributed to Class Members who file valid claims as approved by the Settlement Administrator (the “**Approved Claimants**”) is the Settlement Amount minus (a) Class Counsel fees of \$800,000, plus legal expenses up to \$25,000, both plus taxes, and (c) the Settlement Administrator’s fees and expenses. The remaining amount after deducting these fees and expenses is the **Distribution Fund**.

Each Class Member may obtain a payment in the form of an **Interac E-Transfer equal to the Distribution Fund divided by the total number of Approved Claimants, between a minimum of \$3.00 and a maximum of \$10.00 each**, depending on the total number of Approved Claimants. Each Approved Claimant can only get one Interac E-Transfer regardless of the number of products subject to Ecofees they purchased from Dollarama during the Class Period. If the total number of Approved Claimants results in Interac E-Transfers worth less than \$3.00 each, no Interac E-Transfers will be made and the Distribution Fund will be paid to charities approved by the Court.

In addition to paying the Settlement Amount, Dollarama has voluntarily implemented business practice changes, detailed in the Settlement Agreement, regarding how it displays the price of its products subject to Ecofees.

What are my Options?

1. If you wish to be bound by the proposed Settlement and are a Class Member, you may claim compensation as detailed below (see the next section: “How do I Claim Compensation?”).

2. If you do not wish to participate in the Settlement, you may exclude yourself from the class (“opt out”) by **November 22, 2024**, by sending a written notice to the Court with a copy to Class Counsel. If you exclude yourself, you cannot obtain compensation from this Settlement if it is approved.

3. You may also object to the Settlement, and the Court will consider your objection in whether to approve the Settlement or not, if you are a Class Member. Your objection must be received in writing by the Court by **November 26, 2024**. Please note that the Court cannot change the terms of the Settlement.

4. As a Class Member, you have the right to intervene in the present class action in the manner provided by law. No Class Member other than the Plaintiff or an intervenor may be required to pay legal costs arising from the class action.

The Court will hold a hearing on **December 2, 2024, at 9:30 a.m., in room 15.04** of the Montreal Courthouse (1 Notre-Dame Street East, Montreal, QC, H2Y 1B6) or in any other room designated by the Court, or via a TEAMS link available on the Settlement Website. At this hearing, the Court will consider whether the Settlement is fair and reasonable. You may attend the hearing and you may hire your own lawyer, but you are not required to do so.

How do I claim compensation? If the Settlement is approved by the Court and you are eligible to receive compensation, a notice will be published to inform Class Members of the Settlement and the manner in which to seek compensation. An online Claim Form will be made available on the Settlement website, which you will have to complete and submit by the Claim Deadline specified in the Claim Form, and attest that you purchased at least one product subject to Ecofees from Dollarama in Canada during the Class Period, specifying the city and the province or territory in which the purchase was made. The claims will be validated and approved by the Settlement Administrator.
