TO THE HONOURABLE MADAME JUSTICE PICHÉ, J.S.C., CASE-
MANAGEMENT JUDGE OF THE PRESENT CLASS ACTION, SITTING IN AND
FOR THE DISTRICT OF MONTREAL, YOUR APPLICANT STATES AS
FOLLOWS:

1. On August 16, 2023, an unsuccessful attempt was made to notify Defendant
Poulet with a copy of the Amended Application for Authorization at his only
known physical address. The bailiff wrote on the *procès-verbal* (Exhibit R-1):

« CE QUE JE N'AI PU FAIRE VU QUE LE DESTINATAIRE EST INCONNU
À CET ENDROIT AUX DIRES DU GESTIONNAIRE DE L'IMMEUBLE .

PRENDRE NOTE QUE LE DESTINATAIRE N'EST PAS DANS LE
REGISTRE A L'ENTREE »

2. On October 11, 2024, the law firm Larochelle Avocats filed an Answer on behalf
of Defendant Poulet (Exhibit R-2);



3. On January 24, 2024, the law firm RB Avocats substituted in as attorney of record to represent Defendant Poulet (**Exhibit R-3**);
4. On June 17, 2024, RB Avocats served a notice to cease representing Defendant Poulet (**Exhibit R-4**). The only contact information for Defendant Poulet stated on this notice is:

semiconductors1996@proton.me
5. The Applicants wish to send a formal notice to Defendant Poulet to either appoint another lawyer or to file a notice of intention to self-represent (art. 192 C.C.P.). The Applicants do not know Defendant Poulet's physical address, only his email;
6. Consequently, the Applicants have 2 viable options: (1) ask this Honourable Court to order Larochelle Avocats and RB Avocats to disclose Defendant Poulet's physical address to the Applicants (assuming they are aware), thereby allowing the Applicants to serve Defendant Poulet by bailiff or (2) allow Defendant Poulet to be served by email;
7. Larochelle Avocats and RB Avocats are being served with the present Application out of caution.

FOR THESE REASONS, MAY IT PLEASE THE COURT:

GRANT the present Application;


ORDER Larochelle Avocats and RB Avocats to disclose Defendant Poulet's physical address to the Applicants;

- OR, alternately -

PERMIT notification to be made on Defendant Raymond Poulet by email to semiconductors1996@proton.me and **DECLARE** that such notification is valid for all legal purposes.
