TAKE NOTICE that the Defendant Meta Platforms, Inc. ("**Meta**") hereby opposes the proposed amendments to the *Amended Application for Authorization to Institute a Class Action* notified on April 2, 2026 ("**Proposed Amended Application**").

1. Meta opposes the following amendments:
 - a. Paragraphs 46, and 49 to 51 of the Proposed Amended Application;
 - b. The filing of the additional Exhibits P-27, P-28, P-29 and P-30.

2. The grounds for opposition are that these amendments notably introduce articles containing elements that constitute pure opinions, reference a foreign judicial decision, and are inconsistent with the authorization criteria (art. 575 C.p.c.) and the interests of justice.
3. Due to the connection between the issues raised by these amendments and the arguments to be addressed at the authorization hearing, Defendant respectfully requests that its opposition be considered and argued at the same time.
