## JUDGMENT

(Application for stay of the *Application for authorization to institute a class action*)

- 
- [1] **CONSIDERING** the Plaintiff's allegations in the Application for stay of the *Application for authorization to institute a class action* ("**Application for stay**");
- [2] **CONSIDERING** the exhibit filed in support of the Application for stay;
- [3] **CONSIDERING** the parties representations before the Court;
- [4] **CONSIDERING** the absence of contestation;

### FOR THESE REASONS, THE COURT:

- [5] **STAYS** the present action for a period of up to 60 days after a judgment to be rendered by the Supreme Court of British Columbia on the certification of the case

*Performax Health Group v. Google LLC, Google Canada Corporation, Alphabet Inc., Apple Inc. and Apple Canada Inc.*, no. S-218036 ("**BC Action**");

[6] **ACKNOWLEDGES** the Plaintiff's undertaking to provide the Court with periodic status reports, no more than six months apart, regarding the BC Action and to advise this Court within 30 days of any significant development in the BC Action that may affect the course of the present action;

[7] **CONVENES** the parties to a case management conference to be held within 60 days of the Supreme Court of British Columbia judgment to be rendered on the certification of the BC Action;

[8] **RESERVES** the jurisdiction of the Court to lift this stay on request, or on its own initiative, if the circumstances so warrant;

[9] **THE WHOLE** without costs.
