AFFIDAVIT OF AMIT NEHRA

I, Amit Nehra, Senior Manager of Product, at The TDL Group Corp. (“**TDL**”), having a place of business at 130 King Street West, Suite 300, Toronto, Ontario, being duly sworn, do solemnly swear and answer the questions of the Applicant on my sworn affidavit dated May 13, 2022 (the “**Affidavit**”) as follows. Capitalized terms not otherwise defined herein have the meaning ascribed thereto in the Affidavit:

1. Is there a maximum of number of points that a customer can exchange per day?

Answer: There are no maximum of points that a customer can exchange per day provided in the Terms and Conditions. The Terms and Conditions however provide for a limit of one (1) Eligible Menu Item per redemption transaction and that the maximum number of points that can be redeemed in exchange for one (1) Eligible Menu Item is 220.

1.1. If so, what is the maximum amount?

Answer: See answer to question 1 above.

2. Is there a maximum number of eligible transactions that a customer can make in a certain period of time?

Answer: yes.

2.1. If so, what is the maximum number of transactions?

Answer: There is a limit of one (1) Eligible Transaction per person and per Account per 30-minute period.

2.2. If so, what is the given period of time?

Answer: See answer to question 2.1 above.

3. Is there a maximum number of redemption transactions that a customer can make in a certain period of time?

Answer: no.

- 3.1. If so, what is the maximum number of transactions?

Answer: see answer to question 3 above.

- 3.2. If so, what is the given period of time?

Answer: see answer to question 3 above.

4. Can a customer make more than one redemption transaction per day?

Answer: yes, each redemption transaction being subject to the limitation provided in the Terms and Conditions as explained in my answer to question 1 above.

5. Can a customer make multiple redemption transactions per day?


Answer: yes, each redemption transaction being subject to the limitation provided in the Terms and Conditions as explained in my answer to question 1 above.
