JUDGMENT

[1] The parties were scheduled to proceed on March 30, 2023, with a debate on objections and on April 4, 2023, with the examination of Mr. Galen Weston.

[2] On February 16, 2023, counsel for the Representative Plaintiff informed the Court by email that class counsel in the Quebec bread class action (along with class counsel in the rest of Canada) and the Loblaw/Weston Defendants had scheduled a mediation before Chief Justice Geoffrey B. Morawetz of the Ontario Superior Court of Justice, which will be held at the end of July 2023.

[3] They asked that the deposition of Mr. Weston be postponed until after the mediation. They considered that other procedural steps could still move forward.

[4] Defendants do not agree to have the case move forward as they consider that the examination of Mr. Weston should occur prior to any other significant step in the litigation. However, they do agree to suspend the litigation until the end of July 2023 to allow the mediation to take place.

[5] Given the agreement between the parties, the Court asked that a joint motion to stay be filed.

[6] The parties have now officially jointly requested a stay.

[7] The Court can temporarily stay a class action under articles 49 and 577(2) C.C.P. if a stay is in the interest of class members.

[8] The Representative Plaintiff submits that this is the case here and that it would be preferable for the parties to focus on the mediation rather than on litigation.

[9] While the court is mindful of previous judicial comments complaining about the slow progress of this litigation,¹ it is nonetheless convinced that a stay is in the interest of justice and of class members.

[10] The request for a stay is consistent with the principles of proportionality, judicial economy and could save important costs for all parties.
