CLOSING JUGEMENT

- [1] **WHEREAS** a judgment was rendered on July 11, 2022, approving a Settlement Agreement and Distribution Protocol in the present proceedings;
- [2] **WHEREAS** the parties jointly request the issuance of a closing judgment;

- [5] **CONSIDERING** that the Settlement Agreement was duly implemented and executed by the parties and the claims administrator, MNP Ltd., in accordance with the terms of the Distribution Protocol and the judgment approving same;

- [7] **APPROVES** the final report of MNP Ltd. filed by Sworn Statement dated September 26, 2023;
- [8] **DECLARES** that MNP Ltd. has fulfilled its obligations in accordance with the terms of the settlement approval judgment and is hereby released from its mandate;
- [9] **PRAYS ACT** of the payment of \$160.37 made by MNP Ltd. on June 26, 2023 to the *Fonds d'aide aux actions collectives*;
- [10] **DECLARES** that StockX LLC has fulfilled its obligations under the judgment approving the Settlement Agreement and Distribution Protocol;
- [11] **PRONOUNCES** the closing judgment;
- [12] **THE WHOLE** without costs.
