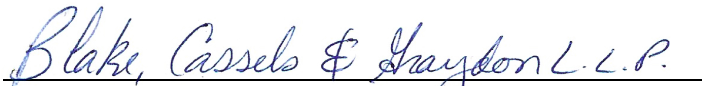
ANSWER OF THE DEFENDANTS
