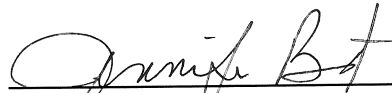

1. I am the Secretary of Kenvue Brands LLC.

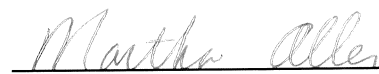

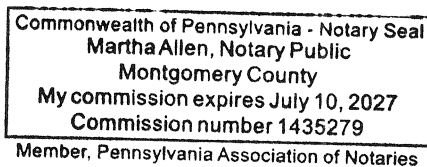
