**JUDGMENT ON DISCONTINUANCE**

---

[1] On December 21, 2009, the Petitioner filed a Motion to Authorize the Bringing of a Class Action & to Ascribe the Status of Representative (Art. 1002 C.C.P. and following);

[2] The group description in the proposed class action is:

- all persons residing in Canada who have purchased and/or used any type of Fixodent denture adhesive products, or any other group to be determined by the Court.

Alternately (or as a subclass)

- all persons residing in Quebec who have purchased and/or used any type of Fixodent denture adhesive products, or any other group to be determined by the Court;

[3] On July 16, 2013, the Petitioner filed a Motion for Discontinuance seeking permission to desist from the present legal proceedings (Art. 1016 C.C.P.), which was amended on July 23, 2013;

[4] On October 10, 2013, the above-mentioned Motion was heard by the Court;

[5] SEEING the above-mentioned Motion and HEARING the representations made by the Petitioner's Co-Attorneys;

[6] CONSIDERING that the Court finds the discontinuance to be in the interest of justice;

[7] **FOR THESE REASONS, THE COURT:**

[8] **GRANTS** the present Motion;

[9] **AUTHORIZES** the Petitioner to discontinue her Motion for Authorization of a Class Action;

[10] **ORDERS** the publication of the full text of the present Judgment to be placed on the website [www.clg.org](http://www.clg.org) and [www.merchantlawgroup.com](http://www.merchantlawgroup.com) for a period of ninety (90) consecutive days following the date of the present Judgment, with a mention allowing for its easy identification on the website's homepage;

[11] **ORDERS** that the full text of the present judgment is to be forwarded by mail or by email to all individuals residing in Quebec who identified themselves on the Co-Attorneys respective websites, in connection with these proceedings;

[12] **WITHOUT COSTS**, as regards the surplus.
