Honourable Justice Corriveau,

Hereinafter is a brief summary of the status of the case and the actions that have been taken since the approval of the settlement in late May 2015.

Sending out the Pre-Approval Notice

As previously mentioned at the hearing approving the Class Action Settlement held on May 28, 2015 and as prescribed in paragraph 29 of the Settlement Agreement (hereafter the "**Agreement**"), the Pre-Approval Notice was published in the media. We have also posted the Pre-Approval Notice on the Haircaresettlement.ca website since April 10, 2015.

Claims and Compensation

From April 10 to July 20, 2015, we received 209 claims: 140 claims from Quebec residents and 66 claims from residents from other Canadian provinces and 3 claims made by residents of the United States. A total of 197 were accepted and the remaining 12 were rejected.

As provided for in paragraph 26 of the Agreement, before making any payment to Claimants, we provided today to Class Counsel, Mtre. Orenstein, an accounting with the following information: all valid and rejected Claim submissions, Pre-Approval Notice costs, amounts due to the *Fonds d'aide aux recours collectifs*, etc. We await Mtre. Orenstein's approval to that effect. Attached are tables of claims with all information regarding claims received, approved and refused.

The approved claims total \$4,545.36, to which should be added the sum of \$27.44 for Representative Debbie Corda's claim, for a total of \$4,572.80.

Fonds d'aide aux recours collectifs

In conformity with Section 47 of the Agreement and as it is provided for at Section 1(3)(a) of the *Règlement sur le pourcentage prélevé par le Fonds d'aide au recours collectifs*, R.R.Q., c. R-2.1, r.2, we will withhold a 2% of the individual payment to each member who is a resident of Quebec and said amount totaling \$62.64 will be remitted to the *Fonds d'aide aux recours collectifs* in due course.
