- [1] **CONSIDERING** the Applicants' Application for Leave to Discontinue;
- [2] **CONSIDERING** the Affidavit in support of the Application;
- [3] **CONSIDERING** the representations of counsel for the Applicant that the discontinuance of the present proceedings will not prejudice the rights of the potential class members;
- [4] **CONSIDERING** that the Application for Leave to Discontinue is not contested by the Respondents;
- [5] **CONSIDERING** that the role of the Court is to protect the rights of the potential class members;

[6] **CONSIDERING** that the court can impose conditions to protect said rights of the potential class members;
