NOTICE TO MEMBERS OF THE CLASS ACTIONS
WITH REGARD TO THE FINANCIAL INVESTMENTS MADE WITH OR THROUGH
MARC JEMUS, FRANÇOIS ROY, ROBERT PRIMEAU
OR THEIR COMPANIES

- 1. TAKE NOTICE that the bringing of two (2) Class Actions was authorized on August 19, 2010 and May 29, 2013 by judgments of the Honorable Justice Michel Déziel of the Superior Court for the benefit of the persons forming part of the group hereinafter described, namely:
  - 1.1. In the matter of David Brown v. François Roy, Marc Jémus, Robert Primeau, B2B Trust and Desjardins Financial Security Investment Inc. (Optifund Investment Inc.) of the Superior Court of the District of Hull bearing number 550-06-000024-068 (hereinafter "Class Action number 1"):

"All those natural persons, and legal persons with less than fifty (50) employees, who have made various investments proposed to them by Marc Jémus, François Roy and/or Robert Primeau, and/or through them, in and/or through companies related to one of them, in the year 2001 to 2005 inclusively".

1.2. In the matter of David Brown v. Lloyd's Underwrites and Samson & Associés Inc. of the Superior Court of the District of Hull bearing number 550-06-000026-113 (hereinafter "Class Action number 2"):

"All those natural persons, and legal persons with less than fifty (50) employees, who have made various investments proposed to them by Marc Jémus, François Roy and/or Robert Primeau, and/or through them, in and/or through companies related to one of them, in the year 2001 to 2005 inclusively".

- 2. The Class Actions shall be hearing in the judicial district of Hull (to be confirmed);
- 3. The status of representative of the class members has been ascribed to Mr. David Brown.

#### THE COMMUN ISSUES

- 4. The principal questions to be dealt with collectively are as follow:
  - 4.1. Did Marc Jémus, François Roy and Robert Primeau act fraudulently with regard to the investments made at their inducement or through their companies by class members?
  - 4.2. Is each of the defendants liable for the financial losses sustained by class members and for the troubles and inconveniences they suffered?

#### **CONCLUSIONS SOUGHT**

The principal conclusion sought is as follows:

**CONDEM** the defendants jointly to compensate the class members for their financial losses and the troubles and inconveniences they suffered.

# PARTICIPATION IN THE CLASS ACTION

- 6. Each member of the group who has not requested his or her exclusion will be bound by any judgment to be rendered in the class actions and/or by any settlement approved by the Court.
- The class members cannot be called upon to pay the costs of the class actions if not successful.
- 8. Any class member can intervene to support the class actions.
