JUDGMENT

- (1) **CONSIDERING** the judgment rendered on September 10, 2020, approving the Plan of Notice and ordering dissemination of the Notice in accordance with the Plan of Notice within fifteen (15) business days of the judgment;
- (2) **CONSIDERING** that this deadline expires on October 1, 2020;
- (3) **CONSIDERING** that the Plaintiff requests that said deadline be extended to October 8, 2020;
- (4) **CONSIDERING** that the Settlement Agreement provides no specific delay for the dissemination of the Notice;
- (5) **CONSIDERING** that the judgment rendered on September 10, 2020, provides that the Parties may apply to this Court for directions with respect to the implementation of said judgment;
- (6) **CONSIDERING** that the Court has been advised that the updating process of some of the Members' addresses has taken longer than originally estimated;

- (7) **CONSIDERING** that the time allotted for the Members to familiarize themselves with the Settlement Agreement and to make arguments or objections before the Approval Hearing scheduled on December 2, 2020 will still be sufficient if the extension is granted;
- (8) **CONSIDERING** that the Class Counsel undertook to present to the Court any arguments or objections received from members even if they are received after the 45-day deadline stipulated in the judgment rendered on September 10, 2020;
- (9) **CONSIDERING** that the Members will continue to have more than one month to file their duly completed Claim Form before the Claims Bar Deadline on November 24, 2020;
- (10) **CONSIDERING** that, if necessary, the Court may be seized with an application to file a Claim Form after the Claims Bar Deadline pursuant to section 14 of the Plan of Allocation, attached as Schedule E of the Settlement Agreement;
- (11) **CONSIDERING** that extending the deadline for the dissemination of the Notice to October 8, 2020 will not adversely affect the rights of the Members and is in the interests of justice;

WHEREFORE, THE COURT:

(12) ORDERS that for the purposes of this judgment, except to the extent that they are modified in this judgment, the definitions set out in the Settlement Agreement apply to and are incorporated into this judgment;

(12) ORDONNE qu'aux fins du présent jugement, sauf si elles sont modifiées dans le présent jugement, les définitions énoncées dans l'Entente de règlement s'appliquent et sont incorporées au présent jugement;


(13) EXTENDS to October 8, 2020, the deadline for the dissemination of the Notice in accordance with the Plan of Notice.
