

**A JUDGMENT SETTING A PEREMPTORY DATE FOR THE TRANSMISSION OF ALL THE NECESSARY DOCUMENTS FOR THE TREATMENT OF YOUR CLAIM WAS RENDERED ON JANUARY 17, 2022, IN THE CLASS ACTION INVOLVING THE VETERANS WHO RESIDED AT SAINTE-ANNE HOSPITAL SINCE APRIL 1<sup>ST</sup>, 2016 UNTIL OCTOBER 30, 2021.**

**THIS JUDGMENT HAS A DIRECT IMPACT ON YOUR RIGHTS.**

**PLEASE READ THIS NOTICE CAREFULLY, AS IT EXPLAINS HOW IT AFFECTS YOUR LEGAL RIGHTS.**

On January 17, 2022, the Court approved plaintiffs *Motion for directives* in the present file.

With this decision, the Court has set the date of **FEBRUARY 18, 2022**, as the **deadline** to transmit to Mazars all the necessary documents for the treatment of your claim.

With this decision, the Court has also approved an increase of the fees payable to Mazars for the administration of the claims, the payment of the second instalment of the indemnity to the Members, as well as the payment of the remaining fees due to plaintiff's lawyers.

**A. What is the purpose of this notice?**

The purpose of this notice is to inform you that you have until **FEBRUARY 18, 2022, AT MIDNIGHT** to transmit to Mazars all the missing documents for the treatment of your claim.

**Following this deadline, if you have not transmitted all the necessary documents, your claim will be denied. You will therefore lose all rights to an indemnity**

**B. Who are the members impacted by the present notice?**

All the members who benefitted from the extended delay to file a claim, but who have yet to transmit all the necessary documents for the treatment of their claim.

**C. How to complete your claim**
